● Product Function Introduction

By connecting to your car's USB-A/USB-C port, your factory wired CarPlay/wired Android Auto can be upgraded to wireless CarPlay/wireless Android Auto, and it can be automatically connected when you get in the car. Let users say goodbye to the shackles of data cable.

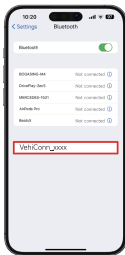

● Wireless CarPlay Connection Steps

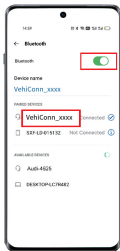
1. Insert the adapter into the car's USB-A/USB-C port
2. Turn on the WiFi and Bluetooth of the iPhone
3. Enter the Bluetooth interface of the iPhone and search for the Bluetooth name displayed on the car screen (Figure1)
4. Tap Connect and agree to use CarPlay in-car to access wireless CarPlay

● Wireless Android Auto Connection Steps

1. Insert the adapter into the car's USB-A/USB-C port
2. Turn on the WiFi and Bluetooth of the Android phone
3. Enter the Bluetooth interface of the Android phone and search for the Bluetooth name displayed on the car screen (Figure2)
4. Tap Connect and agree to use Android Auto in-car to access wireless Android Auto

● Visit the product backend control page

◦ iPhone

Method 1: When CarPlay is connected, iPhone uses Safari/Chrome to visit the URL 192.168.50.100

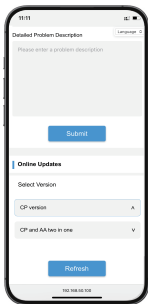
Method 2: When CarPlay is not connected and the product is powered on/signal light is on, iPhone connects to the product's WiFi (**WiFi name: VehiConn_xxxx, password: 12345678**), after WiFi connection, iPhone uses Safari/Chrome to visit the URL 192.168.50.100. 12345678), after the WiFi is connected, iPhone will use Safari/Chrome to visit the URL 192.168.50.100.

◦ Android phone

When Android Auto is already connected, the Android phone can not directly access the product backstage webpage, you need to do the following:

1. in the phone settings, turn off Bluetooth and WiFi, and then turn on WiFi
2. Connect your cell phone to the product WiFi (**WiFi name: VehiConn_xxxx, password 12345678**)
3. After the WiFi is connected, the cell phone can use the browser to access the URL 192.168.50.100.

In the web page, you can modify the setup parameters, give feedback on usage issues, and update the software version.



◦ Tips:

When you give feedback, you need to enter your email address first, and then briefly fill in the problems you encountered, after the submission is successful (Android phones need to turn off the cell phone WiFi and use mobile data to submit), please click to copy the feedback ID that pops up on the webpage, and give the ID to the sales/after-sales staff, and they will follow up to solve the problem.

When updating the version, please keep the power supply of the product stable, don't cut off the power supply on the way of upgrading, the product will restart automatically after the upgrade is completed.
