### Request for acceptance of German national approvals of light sources

We refer to the inquiry of November 22<sup>nd</sup> 2023, regarding the acceptance of national type approval for various LED light sources.

We apologize for the long processing time the case has taken. This is due to the large workload at our department.

#### National type approvals

In the inquiry, Lumileds Holding B.V., represented by Lumileds Commercial France SAS, requests permission to put on the Norwegian market the following products:

Type light source	Approval number

The Norwegian Public Roads Administration (NPRA) has assessed the submitted documentation consisting of the type approval certificate issued by KBA, relevant test reports from technical service and information document from Lumileds Holding B.V. The NPRA finds it acceptable to accept German national approval for the above-mentioned products in accordance with Norwegian national regulations, cf. the motor vehicle regulation (Regulations relating to approval of motor vehicles and their trailers). The products are allowed to be marketed and sold on the Norwegian market. The following conditions are to be met:

This acceptance is valid for the above-mentioned extensions.

Lumileds Holding B.V. is responsible for ensuring that the product sold on the Norwegian market complies with the current approval issued by KBA and accepted by the NPRA. NPRA can inspect the product and, if noncompliance is detected, it can be required that the product will be withdrawn from the market for a period or forever. Likewise, this acceptance can also be withdrawn.

### **Further process**

In the event of changes to the products that lead to an extension of type approval, the Norwegian Road Administration wants information about this to be sent. The reason is further information to the Supervision office and the Roadside Inspection office. Information about changes need only consist of a type approval certificate issued by KBA and an information document from Lumileds Holding B.V. If necessary, we will request extended documentation.

Likewise, we will have information with the last date of sale (if relevant) if production of the products ceases, or type approval issued by KBA is withdrawn. ### **Tacit acceptance**

NPRA will not issue new confirmation of acceptance of extensions on already accepted products unless Lumileds Holding B.V. specifically requests this. If no response is given to the inquiry within 30 days, the product is to be considered approved for sale on the Norwegian market.

When new products are to be launched on the market, complete documentation, i.e. approval certificate, test report and information document, must be attached to the request. In the event of such enquiries, we will send confirmation of acceptance or non-acceptance. Otherwise, the routine described above will be followed.

### **Information to retailers/customers**

Lumileds Holding B.V. is responsible for information regarding approval and installation of the light source to the retailers and customers. This information can be on the packaging of the product or in a separate folder supplied with the product. Likewise, we accept that information is given via the manufacturer's own website as a substitute for a physical document (confirmation issued on paper).

**Current law**

Acceptance of approvals for vehicles is authorized in Norwegian law through the vehicle regulations. However, it is the case that national type approvals for systems, components and technical devices issued by other EU/EEA member states are not covered by the legislation. We nevertheless find that we can accept approvals mentioned in this document with justification in § 17-2 Exception based on the national German approvals for the light sources mentioned in this document.
